TERMS AND CONDITIONS OF PARTICIPATION

- The price includes the participation of one person in selected events.

- Upon the reception of the application form, a confirmation will be sent together with a pro-forma invoice.
- Payment should be made within 14 days after the registration but no later than before the conference.
- The payment shall be made on the bank account given on the invoice.
- Resignation ought to be sent by registered mail to the address of the organizer.
- In case of resignation until 26th of October 2017, the participant will be charged the administrative fee in the amount of 400 PLN + 23% VAT.
- In case of resignation after 21st of September 2017, the participant will be charged full cost of the participation.
- If the participant does not issue written resignation or does not take part in the event, he will be charged full cost of participation.
- Lack of payment is not tantamount to the resignation from the participation.
- In case of absence of the registered participant, another member of the company can take his place. The change should be submitted up to 7 days before the conference.
- The organizer reserves the right to change the agenda of event, location and lecturers.
